The autopsy and notification to the next of kin have been completed on the male black found deceased in the 5100 block of Plaza Drive, on Thursday October 22, 2015. The deceased has been positively identified as Brandon Terrell Washington, male black age 20, from Fort Wayne, Indiana. Brandon Terrell Washington was pronounced dead at the scene and taken to the NEIFC for autopsy.

The Cause of Death was determined to be Gunshot Wound(s) and the Manner of Death is Homicide.

Brandon Terrell Washington is the 24th homicide in 2015 in Allen County. This incident remains under investigation by the Fort Wayne Police Department, the Allen County Coroner's Office, and the Allen County Prosecuting Attorney's Office.

The autopsy and notification to the next of kin have been completed on the female black found deceased in the 900 block of East Wayne Street, on Friday October 23, 2015. The deceased has been positively identified as Anastasia LaShawn Butler, female black age 16, from Fort Wayne, Indiana. Anastasia LaShawn Butler was pronounced dead at the scene and taken to the NEIFC for autopsy.
