The autopsy has been completed and notification has been made to the next of kin on the deceased male discovered in the parked vehicle in the alley, near Pontiac and Anthony Blvd. during the early morning hours of March 26, 2016. The deceased has been positively identified as Shawn R. Reinhart, male white, 40 years of age of Monroe, Indiana. Shawn Reinhart was found after reports of shots fired and death was pronounced on scene. The autopsy was performed with the Cause of Death being Gunshot Wound(s) and the Manner of Death being Homicide. Mr. Reinhart is the 7<sup>th</sup> homicide in Allen County in 2016. This incident remains under investigation by the Fort Wayne Police Department, the Allen County Coroner's Office and the Allen County Prosecuting Attorney's Office.

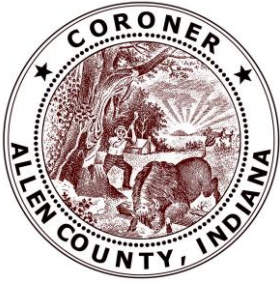
The Allen County Coroner's Office has positively identified the driver involved in the single motor vehicle crash, located in the 2800 block of Webster Road. The deceased has been identified Neil Burd, male white, 39 years of age, of Fort Wayne, Indiana. Mr. Burd was ejected from his vehicle and died at the scene. The Cause of Death is Blunt Force Injuries due to Motor Vehicle Crash and the Manner of Death is MVC/Accident. Mr. Burd is the 8<sup>th</sup> MVC/Accident death in Allen County in 2016.
