The Allen County Coroner's Office was notified of the death of Sharon I. Shively, female white 72 years of age, on Saturday, July 2, 2016. Sharon Shively was removed from a neighborhood pond, after she entered the water to rescue a child, in the late morning hours of Friday, July 1, 2016. Sharon Shively was transported from the scene to a local hospital and was admitted. The Cause of Death is Anoxic Brain Injury due to Drowning, and the Manner of Death is Accident.

The autopsy has been completed and next of kin has been notified on Dominic Javon Norton, male black 28 years of age, of Fort Wayne, Indiana, who was found suffering from gunshot wounds in the 4100 block of Euclid Street, on July 5, 2016 just after midnight. Dominic J. Norton was transported from the scene to a local hospital where he died at 09:19 on July 5, 2016. The Cause of Death is Gunshot Wound(s), and the Manner of Death is Homicide.

Dominic Javon Norton is the 18<sup>th</sup> Homicide victim in Allen County for 2016.

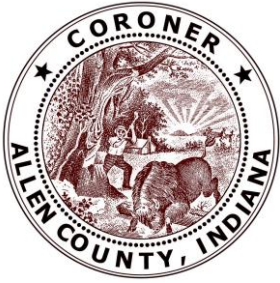
This incident remains under investigation by the Fort Wayne Police Department, the Allen County Prosecutors Office and the Allen County Coroner's Office.

The autopsy has been completed and next of kin has been notified on Edword L. Kiel, male black 28 years of age, of Fort Wayne, Indiana, who was found suffering from gunshot wounds in the 3400 block of McKinnie Avenue, on July 6, 2016 at about 01:34.
