The autopsy has been completed and the next of kin has been notified for Jeffrey Martin Lute, male white 28 years of age from Fort Wayne, Indiana. Jeffrey Lute was found suffering from gunshot wound(s) in the parking lot of the Texas Roadhouse, 700 block of West Washington Center Road, Ft. Wayne, Indiana at about 2130 hours on August 14, 2016. Jeffrey Lute was pronounced dead at the scene.

The Cause of Death has been determined to be Gunshot Wound(s) and the Manner of Death is Homicide.

Jeffrey Martin Lute is the 23<sup>rd</sup> homicide victim in Allen County for 2016.

This incident remains under investigation by the Fort Wayne Police Department, the Allen County Prosecutor's Office and the Allen County Coroner's Office.

The autopsy has been completed and the next of kin has been notified for Brian Quintana, male Hispanic 18 years of age from Fort Wayne, Indiana. Brian Quintana was found suffering from gunshot wound(s) in the 1900 River Run Trail, Ft. Wayne, Indiana at about 2200 hours on August 14, 2016. Brian Quintana was transported to a local hospital, and death was pronounced.
