The autopsies have been completed and notification has been made to the next of kin on the three persons found deceased inside the home in the 3000 block of Holton Avenue, Fort Wayne, Indiana at about 04:00 hours on September 11, 2016.

The first deceased individual has been positively identified as Traeven Harris, male black 18 years of age, of Fort Wayne, Indiana. The Cause of Death is Gunshot Wound(s) and the Manner of Death is Homicide. Traeven Harris is the 28th homicide in Allen County in 2016.

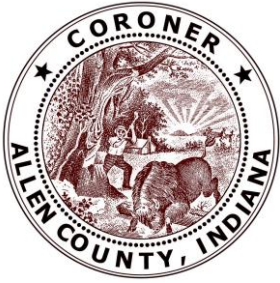
The second deceased individual has been positively identified as Dajahiona Arrington, female black 18 years of age, of Fort Wayne, Indiana. The Cause of Death is Gunshot Wound(s) of the Head, and the Manner of Death is Homicide. Dajahiona Arrington is the 29th homicide in Allen County in 2016.

Dajahiona Arrington was pregnant at the time of her death and the unborn fetus was of a viable age if born. The Cause of Death for Baby Boy Arrington has been determined to be Intrauterine Demise due to Gunshot Wound(s) of the Head to the Mother and the Manner of Death is Homicide. Baby Boy Arrington is the 30th homicide in Allen County in 2016.

The third deceased individual has been positively identified as Consuela Arrington, female black 37 years of age, of Fort Wayne, Indiana. The Cause of Death is Gunshot Wound(s) and Stab Wound(s) the Manner of Death is Homicide. Consuela Arrington is the 31st homicide in Allen County in 2016.
