The autopsies have been completed and notification has been made to the next of kin on the deceased persons from the shooting investigation in the 1200 block of Lillie Street, Fort Wayne, Indiana at about 0635 hours on January 20, 2018.

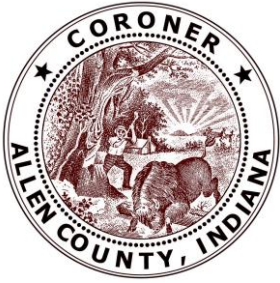
The first deceased individual has been positively identified as Preonda M. Jones, female black 37 years of age, of Fort Wayne, Indiana. Preonda Jones was located inside the home and was pronounced deceased at the scene. The Cause of Death is Gunshot Wound(s) and the Manner of Death is Homicide. Preonda M. Jones is the 3rd homicide in Allen County in 2018.

The second deceased individual has been positively identified as Brianna R. Gould, female white 24 years of age, of Fort Wayne, Indiana. Brianna R. Gould was located at the scene suffering from gunshot wounds and was transported to a local hospital, where death was pronounced. The Cause of Death is Gunshot Wound(s), and the Manner of Death is Homicide. Brianna R. Gould is the 4th homicide in Allen County in 2018.

Brianna R. Gould was pregnant at the time of her death and the unborn fetus was of a viable age if born. The Cause of Death for Baby Boy Gould has been determined to be Intrauterine Demise due to Gunshot Wound(s) and the Manner of Death is Homicide. Baby Boy Gould is the 5th homicide in Allen County in 2018.
