The Allen County Coroner's Office has determined the Cause of Death to be Gunshot Wound of the Head and the Manner of Death has been ruled as Homicide, in the death of Brandon Edward Bittner.

Brandon Edward Bittner is the 31<sup>st</sup> homicide in Allen County for 2018.

The autopsy has been completed and notification has been made to the next of kin of Brandon Edward Bittner, Male White 27 years of age, from Fort Wayne, Indiana.

Brandon Edward Bittner was found suffering from a gunshot wound, in a home in the 9400 block of Greyhawk Drive, Fort Wayne, Indiana, during the evening hours of Monday, June 26, 2018. Emergency services were dispatched to the scene and Brandon Edward Bittner was pronounced deceased on the scene.

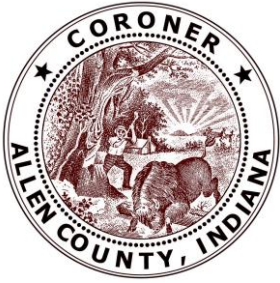
The Cause of Death has been determined to be Gunshot Wound of the Head and the Manner of Death is Pending Further Investigation.
