Paul Schmucker, Jr. was on a 4 wheel ATV, which was involved in a single vehicle crash in the 16900 block of Hurshtown Road, Spencerville, Indiana during the evening hours of Thursday, September 20, 2018.

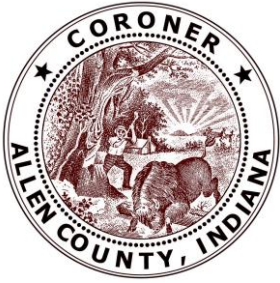
The Cause of Death has been determined to be Blunt Force Injuries and the Manner of Death is Accident.
