The autopsies have been completed, identification has been made, and the next of kin has been notified with regards to the three victims found in the house fire in the 1800 block of Rosemont Drive, on Friday, April 10, 2020, at approximately 01:09 hours.

The Fort Wayne Police Department discovered the active fire and requested Fort Wayne Fire Department. When the Fort Wayne Fire Department arrived, they found a victim and removed him from the burning residence. He was transported to a local hospital where death was pronounced. During a subsequent search two additional individuals were located and pronounced deceased at the scene.

All three individual were transported to the Northeast Indiana Forensic Center for an autopsy.

Identified within the residence was Doak Stanley McBride, male, white, age 51, of Fort Wayne, Indiana. His cause of death is pending and the manner of death is pending the final autopsy report.

Identified within the residence was Marcos Ildefonso Casares, male, hispanic, age 37, and is listed as homeless. His cause of death has been determined to be Multiple Gunshot Wound(s) and the Manner of Death is Homicide.

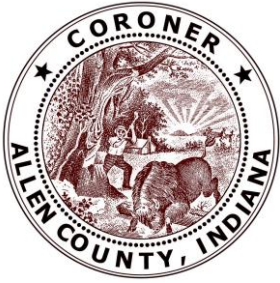
This is the 11<sup>th</sup> Homicide in Allen County for 2020
