On Friday January 7, 2022 at about 2100 hours the Allen County Coroner's Office was notified of a single vehicle fatal crash located at the intersection of Indianapolis Road and Smith Road. The vehicle left the roadway, struck an embankment, fence and overturned. The driver of the vehicle, Brian L. Call male white 48 years of age, from Fort Wayne, Indiana was pronounced deceased at the scene of the crash by medics.

The next of kin has been notified of the death.

The Cause of Death has been determined to be Multiple Blunt Force Injuries due to Motor Vehicle Crash and the Manner of Death is Accident.

Brian L. Call is the 2nd Fatal Motor Vehicle Crash in Allen County for 2022.

This incident is under investigation by the Allen County Sheriff's Department, the Allen County Prosecutor's Office and the Allen County Coroner's Office.

On Saturday, January 8, 2022 at about 1800 hours the Allen County Coroner's Office was notified of the death of Corbin James Reed, male white 28 years of age, from Yoder, Indiana.

Corbin James Reed was the passenger in a motor vehicle which left the roadway, struck a pole and rolled over. The crash occurred in the 5700 block of Lower Huntington Road, Ft. Wayne, Indiana. Corbin James Reed was transported from the scene to a local hospital where death was pronounced.

An autopsy has been performed and the next of kin has been notified of the death.
