The autopsy has been completed and the next of kin has been notified of Delonte Corvon Walker-Ross, male black 18 years of age, from Fort Wayne, Indiana who was found suffering from gunshot wounds, inside a home in the 1500 block of Oxford Street, during the early morning hours of Saturday, December 23, 2017. The Fort Wayne Police Department responded to the home ref. a shooting investigation. Two individuals were found with gunshot wounds, one was transported from the scene to a local hospital and Delonte Corvon Walker-Ross was pronounced deceased at the scene.

The Cause of Death for Delonte Corvon Walker-Ross is Gunshot Wound(s) and the Manner of Death is Homicide.

This remains under investigation by the Fort Wayne Police Department, the Allen County Prosecuting Attorney's Office and the Allen County Coroner's Office.

Delonte Corvon Walker-Ross is the 40th homicide in Allen County for 2017.

Shortly after being notified of the shooting investigation in the 1500 block of Oxford Street a second shooting investigation was reported.

The autopsy has been completed and the next of kin has been notified of Deandre Anthony Voss, male black 32 years of age. Deandre Anthony Voss was located in the 1400 block of Greene Street suffering from gunshot wounds. Deandre Anthony Voss was pronounced deceased at the scene.

The Cause of Death is Gunshot Wound(s) and the Manner of Death is Homicide.

This incident continues to be investigated by the Fort Wayne Police Department, the Allen County Prosecuting Attorney's Office and the Allen County Coroner's Office.

Deandre Anthony Voss is the 41st homicide in Allen County for 2017.
