The Allen County Coroner's Office was notified of the death of Jason Tavassol, Male White 37 years of age from Fort Wayne, Indiana. Jason Tavassol was involved in a motor vehicle crash on December 12, 2017 near the intersection of Coldwater Road and Laddie Lane. Jason Tavassol fell off of a moving vehicle, landing in the roadway and was struck by a passing motorist. Jason Tavassol was transported from the scene to a local hospital where he died on December 14, 2017 from the injuries sustained.

The Cause of Death is Blunt Force Trauma due to Motor Vehicle Crash and the Manner of Death is Accident.

Jason Tavassol is the 40th fatal motor vehicle crash in Allen County for 2017.

This crash was investigated by the Fort Wayne Police Department, the Allen County Prosecuting Attorney's Office and the Allen County Coroner's Office.

The Allen County Coroner's Office was notified of the motor vehicle crash located at the intersection of Pontiac and Clinton Streets, Fort Wayne, Indiana, during the early morning hours of Saturday, December 16, 2017. Chelsie A. Montgomery, Female White 29 years of age, from Fort Wayne, Indiana was the unrestrained driver of a motor vehicle which was struck by a second vehicle. Chelsie A. Montgomery was ejected from her vehicle and was found in the roadway. Chelsie A. Montgomery was pronounced dead at the scene.

Chelsie A. Montgomery is the 41st fatal motor vehicle crash in Allen County for 2017.

This crash is being investigated by the Fort Wayne Police Department, the Allen County Prosecuting Attorney's Office and the Allen County Coroner's Office.

The Allen County Coroner's Office was notified of the motor vehicle crash located in the 3800 block of Ferguson Road, Fort Wayne, Indiana, during the early afternoon hours of Monday, December 18, 2017. Daniel J. Simpson, Male White 61 years of age, from Fort Wayne, Indiana was the restrained driver of a motor vehicle which was struck by a second vehicle. Daniel Simpson was pronounced dead at the scene.

The Cause of Death is Blunt Force Trauma due to Motor Vehicle Crash and the Manner of Death is Accident.

Daniel Simpson is the 42nd fatal motor vehicle crash in Allen County for 2017.

This crash is being investigated by the Fort Wayne Police Department, the Allen County Prosecuting Attorney's Office and the Allen County Coroner's Office.
