The Allen County Coroner's Office was contacted and notified of the death of Nina R. Wold, 75 years of age, from Peru, Indiana. Nina Wold was the restrained passenger involved in a motor vehicle crash located in the 8800 block of US 24 West, at about 13:10 hours on February 25, 2021. Emergency services were dispatched to the scene and Nina Wold was transported to a local hospital. Nina Wold was admitted to the hospital where she remained until death was pronounced on March 11, 2021.

The next of kin has been notified of the death. The Cause of Death is Blunt Force Injuries due to Motor Vehicle Crash and the Manner of Death is Accident.

Nina R. Wold is the 9th fatal motor vehicle crash for Allen County in 2021.

This crash is being investigated by the Indiana State Police, and the Allen County Coroner's Office.

The Allen County Coroner's Office was notified of the death of Shirley Evans, female white 88 years of age, from Fort Wayne, Indiana. Shirley Evans was the restrained passenger involved in a motor vehicle crash located in the intersection of Coldwater Road and Dupont Road, Fort Wayne, at about 12:30 hours on March 11, 2021. Emergency services were dispatched to the scene and Shirley Evans was transported to a local hospital. Shirley Evans was admitted to the hospital where she remained until death was pronounced on March 12, 2021.
